TARIFF PROVISIONS

- 1. This tariff is charged for regular working time during the week: from Monday till Friday, from 5 a.m. to 10 p.m. and on Saturdays from 5 a.m. to 2 p.m.
- 2. For overtime work:
 - during the week from 10 p.m. to 5 a.m. the tariff is increased by 50 %
 - on Saturdays from 2 p.m. to 10 p.m. the tariff is increased by 75 %
 - on Saturdays from 10 p.m. to Monday 4 a.m. the tariff is increased by 100 %

In case the overtime work is performed within the following period, the tariff is increased by 150 %:

- on the day before holidays and working free days from 10 p.m. to 00 a.m.
- on the day after holidays and working free days from 00. a.m. to 5 a.m.
- on public holidays and working free days.
- 3. Shifting of vessels from pier to pier of turning the vessels shall be charged as mooring or unmooring.
- 4. In case the mooring or unmooring is done under difficult circumstances (metal ropes, chains, higher number of ropes, partial mooring at a buoy,...) the price shall be charged upon special agreement. The minimum price increase should be 10%.
- 5. The services, for which the price is not determined in this tariff, should be agreed upon the General Tariff Terms of the Tariff of Handling, Storage and Additional services or upon a separate written agreement. In the event that the customer has not concluded a special Payment For Services Contract with Luka Koper Inpo in which terms of payment are agreed, the customer shall be obliged to settle the invoice for services performed within 15 days of the invoice date. Luka Koper Inpo shall issue

the invoice no later than five days from the provision of the service; the invoice date shall mark the commencement of the debtor-creditor relationship, and payment should be remitted to the account identified by Luka Koper Inpo.

6. This Tariff shall become effective with 26th January 2004.
