Port machinery wash-service tariff supplements

- 1. Tariffs do not include VAT charged in compliance with the pertinent legislation.
- 2. Regular working hours are from Monday to Friday between 6 am and 2 pm.
- 3. For washing services performed out of regular working hours a prior arrangement shall be made. This arrangement must be confirmed in a written form by a person in charge of the wash. For ordering washes out of regular working hours please contact the following tel. numbers: +386 31 636 612 or +386 41 349 193. Tariff for services out of regular time:
 - For overtime during workdays (from 2 pm till 10pm) the Tariff charged is 50% higher than the standard rate
 - Saturdays (from 6 am until 2 pm) the Tariff charged is 75% higher than the standard rate Wash services out of mentioned periods can be made upon prior arrangement.
- 4. Services not included in the Tariff Table:
 - dusting vehicles with soda: washing tariff is 20% higher
 - tariffs for vehicles not included in the above Table shall be charged on the basis of a comparable vehicle
 - in the event that there is no other basis for calculation. charges shall be levied on the basis of an hourly rate of 25 EUR per hour. with half-an-hour being the minimum amount;
 - in the event that materials need to be removed from a vehicle prior to washing. such removal is charged for on the basis of the hourly rate (see above). and the disposal of such material is charged for at a rate of 210 EUR per cubic meter. The client and the contractor shall together estimate the amount of any such materials.
- 5. Payment for regular customers with contract shall be due within 20 days of service provision. Occasional custumers shall pay the immediately on site.
- 6. This Tariff becomes effective as of 1st July 2008.
