PROVISIONS TO THE TABLE

- 1. The takeover and cartage of waste within the Port of Koper facility is provided by Luka Koper INPO d.o.o.
- 2. The cost of these services does not include sales tax which is levied on the customer in accordance with pertinent legislation.
- 3. Regular working hours are from Monday to Friday between 7 am and 3 pm.
 - overtime from Monday to Friday between 3 pm and 11 pm is charged at time-and-a-half (i.e. + 50%);
 - overtime on Saturdays is charged at time-and-three-quarters (i.e. + 75%); while overtime night work from 11 pm to 7 am and Sundays are charged at double-time (i.e. + 100%);
 - extra hours on national and bank holidays are charged at double-time-and-a-half (i.e. + 150%).
- 4. The removal and/or disposal of any waste that is not included in this Price List, as well as any deviations from the Price List are subject to a written agreement between the parties.
- 5. The Contractor reserves the right to change prices on the basis of any changes in conditions on external markets.
- 6. Independent delivery to the recycling yard of the Waste Handling Centre or to the midden is possible only upon a prior agreement.
- 7. This Price List does not include wastes from ships or biological waste that is undergoing putrefaction.
- 8. For waste generators who cause up to 0.25 m3 of waste per month, a monthly flat rate of 0.25 m3 of mixed municipal waste is calculated.
- 9. Payment for services provided shall be due within 20 days of the rendering of said services. Interest shall be levied on overdue payments in accordance with the law RS.
- 10. This Price List is valid as of 1st January 2020.
