

## TARIFF

### FOR PROVISION OF MANDATORY UTILITY SERVICES FOR WASTE COLLECTION FROM VESSELS IN THE PORT OF KOPER AREA

Published on the basis of the Decree on the determination of prices for mandatory utility services for waste collection from vessels at the Port of Koper (Official Gazette No. 120/05 of 29<sup>th</sup> December 2005), and the amendment to the aforementioned Decree (Official Gazette No. 17/06 of 17<sup>th</sup> February 2006).

The specified amounts, prescribed in Table 1 and Table 2, shall be levied upon landing as well as upon the commencement of each ensuing 24-hour period that the vessel remains at the port.

2 The collection of solid waste from a vessel shall be charged for on the basis of volume. Volumes of less than 0.5 m<sup>3</sup> shall not be charged for. Charges shall be according to the actual volume of waste collected, rounded up to the nearest 0.5 m<sup>3</sup>.

In the event that the density of mixed (unsorted) municipal refuse exceeds 500 kg/m<sup>3</sup>, collection shall be charged for on the basis of weight; the tariff for the collection of mixed (unsorted) municipal refuse is 100 EUR per metric tonne.

# 3 The collection of liquid waste from a vessel shall be charged for on the basis of volume; the minimum chargeable quantity is 1 m<sup>3</sup>.

4 The carting of solid and liquid wastes with auxiliary vessel from ship to the port facilities is charged for on the basis of the cost of removal by an auxiliary vessel.

In the event that solid waste is collected from a vessel at anchor by a vessel removing oil/water or other liquid wastes, such removal of solid waste shall not be charged for.

### 5 Tariff supplement for the collection and carting of waste from a vessel by an auxiliary vessel.

6 The above charges do not include charges arising from the processing and removal of mixed or hazardous wastes. Such shall be charged for on the basis of the actual cost of their removal, management and disposal.

This Tariff comes becomes effective as of 18<sup>th</sup> February 2006.

Payment is due 20 days of service provision. For payments after this period statutory delay interests will be charged.

As to the performance of mandatory utility services for waste collection from vessels in the Port of Koper area, the following conditions should be observed:

Connecting a pipeline (or other tubing) from the collector to a flange on board the vessel shall be the obligation of the vessel's crew. Any such flange must comply with international maritime standards (in the event of a non-compliance the client is obliged to provide a standards-compliant alternative). The vessel must be equipped with a functional pump capable of transferring waste liquids from any storage tank to the collection truck ashore.

The vessel's agent is obliged to inform the master that a representative or crewmember should oversee the pumping of waste, as well as ensure that a pumping operation is immediately halted in the event of any danger or spillage.

Any service that is not included in this Tariff is encompassed by the Tariff on General Provisions For Handling, Warehousing and Additional Services of Luka Koper d.d.
